## **Not Included**

We are not responsible for your round trip flight to and from Mexico City. Also not included are food or drink that are not specified in the journey materials, items of a personal nature such as laundry, gifts, shopping, beverages, toll calls, excess baggage, medical costs, and the costs of hospitalization and evacuation from remote areas, insurance and additional expenses arising from the delay or extension of a trip due to weather, political disputes, sickness, failure of transportation, or other causes beyond our control.

## **Payment**

A \$250.00 non-refundable deposit is due at the time of registration. The remainder is due two weeks prior to the journey. Payment can be made by cash, cashier's check, money order, PayPal, Visa, Mastercard, Discover or American Express. Cashier's checks or money order must be made out to Healing Heart Center. We will not make exceptions to this policy.

## **Cancellation and Refunds**

If cancellation occurs 60 or more days before departure, your \$250.00 deposit can be used toward another Healing Heart Center journey or event. For cancellation within 60 days prior to departure, refunds are unavailable. In the event that you must cancel your registration for a journey, please put the request in writing to Healing Heart Center, Beyond Insight Division.

We strongly recommend Travel Insurance if there is a chance you may have to cancel your flight for any reason. Sage de Beixedon Breslin, Ph.D. and Healing Heart Center reserve the right to cancel any trip prior to departure for any reason whatsoever, including an insufficient number of participants or logistical problems (e.g. acts of God, war, strikes, etc.), which may impede trip operations. The refund of all payments as described in the paragraph below shall release Sage de Beixedon Breslin, Ph.D. and Healing Heart Center from any further liability. A trip cancellation due to insufficient numbers would normally occur at least a month prior to departure, unless acts of God, war, strikes or other events impede our departure causing large numbers of participants opt to cancel participation on the journey in the last days before departure.

Sage de Beixedon Breslin, Ph.D. and Healing Heart Center must make substantial payments to vendors (including providers of land travel) far in advance of the scheduled date on which we embark. ## *The Journey Agenda*

**Day 1** Following your arrival in the Mexico City airport, move through immigration and change currency if you need to do so. Proceed to the Baron Rojo (Red Baron) Restaurant just outside customs and immigration in Terminal 1. If you arrive in Terminal 2, please take the train to Terminal 1 and meet the group. We will be departing from the airport by chartered vehicle at approximately 5:30 pm. We will travel to the village of Teotihuacan and check into the Villas Arqueologicas, then eat dinner together.

**Day 2-4** We will spend the next four days exploring and moving through the site of the pyramids, working as a group, and also one-on-one. The pyramids provide a natural series of practices and ceremonies that will guide us from the Temple of Quetzalcoatl, up the Avenue of the Dead, towards the Pyramid of the Moon. Our ascension and evolution will culminate atop the Pyramid of the Sun on our last day on site. The journey will provide us with an opportunity to regard the obstacles that we have placed, invited and allowed in our lives, and to determine whether or not they serve us. When we have discerned what we need to leave behind, we will release the life and story that we have lived, so we can move forward to a healthier reality. We will address those issues which impact us physically, emotionally, cognitively and spiritually as we move through Teotihuacan's plazas of Earth, Water, Air, and Fire. Through our introspection and surrender we will emerge and reconnect to the Divine Feminine energy at the Pyramid of the Moon. There are opportunities to experience transformative energies and connections to the Masters in the Temple of the Jaguars and in the Palace of the Butterflies. Our final day unites us with the Divine Masculine energy atop the Pyramid of the Sun.

**Day 5** We will travel by chartered vehicle to Mexico City at approximately 10 am, arriving in Mexico City at approximately 11 am. If there is interest in visiting the Basilica, we can make arrangement to do so. If there is not, we will travel directly to the airport. Should you have an earlier flight than the majority of the group, we will arrange transportation by taxi for you, but be advised that you will be responsible for paying for the taxi (approximately \$65).

# PACKING LIST AND OTHER IMPORTANT INFORMATION

We are delighted you are joining us for the upcoming journey to Teotihuacan. We ask you to carefully read the following information to ensure that your experience is as physically comfortable and spiritually rewarding as possible. Each sacred journey invariably includes two itineraries. On the physical part of the journey, we each travel as a member of a group to places of extraordinary beauty, power and enchantment. On the inner journey, we travel solo down a long, winding road that is often rife with potholes, detours and rivers to cross with no bridge in sight. The outer journey requires that we pack **good shoes, a hat, suntan lotion and bug repellent**. The inner journey requires that we bring along all of our love and courage to honestly deal with ourselves and see what is truth and what is illusion. The physical journey invites only our sense of humor and flexibility. But, our inner journey asks that we identify and begin dismantling the false assumptions upon which we have built our lives. The inner journey is the hardest one we ever make. But, the Toltec have traveled before us and mapped a road we can follow to transcend fear and reclaim our divine birthright of unconditional happiness. With the wisdom of our guides available to support and advise us, we can change our perception. The resulting death of ignorance and resurrection of awareness will speed our journey into the freedom beyond. Our outer journey is intended to follow this map to freedom. **To aid in your physical comfort, we strongly recommend that you pack the following:**

## **Mandatory Items:**

- You must have a valid Passport
- Money for extra food and personal expenses.
- Daily meals and water are provided.
- Water bottle suitable for carrying during the day. Bottled water will be provided. We strongly recommend brushing your teeth with purified water during your stay and do not allow water to run into your mouth when you shower.
- Sturdy walking shoes suitable for climbing pyramids and daily treks.
- Any prescription medication.

## **Suggested Items:**

- Personal items and toiletries
- Journal and pen/pencil
- Rain poncho
- Backpack or fanny pack for transporting items/water on the daily outings. The size of this device is dependent on the amount of belongings you prefer to carry with you!
- Snacks that are portable and do not melt in the warm sun.
- Band-aids, traveler's remedies, and any prescription medication that you *may* need
- Sunscreen (the altitude is high and the sun is strong during the day)
- Hat/Visor
- Alarm Clock
- Personal Pillow (if desired)
- Sunglasses
- Casual, comfortable clothes that you can layer and that are suitable for walking, and sitting while in the pyramid grounds
- Warmer clothes for the evening and early morning
